4. MAYORAL REPORT

The Chief Executive Officer invited the Mayor to report on her term of office in 2017/18.

Dignitaries, visiting Councillors and Mayors, fellow Councillors, Mr CEO, Executive Staff, Community Representatives, family, and friends.

I would like to acknowledge the dedication and expertise of my fellow Councillors – who work incredibly hard in the interest of their Wards, and for the greater good of the Shire, and our CEO, Mr Pinyon, our Directors, Managers and staff, who put in 100% to ensure our Council Plan is being delivered on target and that we are being responsive to the community.

I have great pleasure in reporting to you on some of the achievements and activities of Loddon Shire over the past year. I have had a busy year, representing Loddon at a local, regional and national level, and building on past relationships, and establishing new ones, with our neighbouring councils and regional leaders that will hold us in good stead going forward.

These relationships enable our Council to work collaboratively with our neighbours, and our CEO and staff now have a number of joint projects with other councils that will enable more efficient and economical delivery of services to our shire.

We have joined with seven other councils to our north, including over the river into NSW, in a joint submission to the Federal Government's Regional Growth Fund. Our application was one of more than 300 applications Australia wide. It has progressed to the next stage, being one of only 16 projects invited to progress to the submission of a Full Business Case. If successful, this funding should net us around \$1.7m towards our Caravan Park upgrades, and Stage 2 of the Bridgewater foreshore project.

We have invested in infrastructure projects that enhance the livability of our towns and region: our streetscapes (with Wedderburn's Streetscape Project being officially opened just this week), footpath upgrades in Pyramid Hill, our road and bridge network, and secure water supplies. Stage 2 of the South West Loddon Pipeline Project is now well underway, and will no doubt change the landscape in that part of the shire. We continue to advocate strongly for the Mitiamo Pipeline, which will supply the Mitiamo township and 80,000ha of farmland with permanent, reliable water, providing new economic development opportunities.

I have also chaired the Murray River Group of Councils over the past year, emphasizing to the Commonwealth Government, in the strongest possible terms, the detrimental impact our communities would experience if further on-farm water was removed from our irrigation district under the Murray Darling Basin Plan.

Along with some of our Filipino residents, I have had several opportunities to share Pyramid Hill's experience of Rural Migration. These opportunities have created some great, positive media coverage, but the driver is addressing the much bigger issues of population decline, and skilled labour shortages in rural Victoria.

Our staff have been racing the clock to get our five swimming pools ready for the coming season. All of our pools are now between 50 and 60 years old, and the cost of maintaining them will continue to rise, however we know how vital these facilities are for healthy resilient communities, and will continue to invest in keeping these facilities safe and attractive family gathering places during our long, hot summers.

With state & federal elections around the corner, the Priorities Document we have developed has been put to effective use, finding its way into the office of a number of MPs. This Document outlines the benefits, and the funding, required to deliver a number of significant Projects such as the Pyramid Hill Community Centre development, the Donaldson Park Pavilion upgrade and replacement of our aging Caravan park amenities blocks, to help our populations to grow, our businesses to prosper, and our communities to thrive.
